**CAS STATEMENT:**

You do not need to submit your CAS statement when applying for your visa but you will need to use the details provided to complete your visa application form. **IMPORTANT:**

When you apply for your visa it is essential that you read the [Tier 4 \(general\) guidance](#) on the Home Office's website. Please also visit our website for [information about the documents you must prepare](#) for your visa application.

It is your responsibility to ensure that you meet all the requirements and provide all the information as required by UK Visa and Immigration in the correct format. Failure to do so may lead to your visa application being refused which could impact on your studies.

The most common reason for visa refusals is because the financial documents provided do not meet the requirements. You can check that yours are ready to send using our [bank statement flowchart](#).

Please note that you may be interviewed as part of the visa application process. The interview will focus on your reasons for coming to the UK. You must be able to explain this in English. You may be asked about your course, studies or finances. If you are asked to attend an interview and you fail to do so without reasonable explanation your visa application will be refused.

**Tuberculosis test (TB):**

Please make sure you submit a valid tuberculosis (TB) medical certificate with your visa application if required. You must take a tuberculosis (TB) test if you are coming to the UK for more than 6 months and are resident in any of [these countries](#).

**Immigration Health Surcharge (IHS):**

The [Immigration Health Surcharge](#) (IHS) covers medical treatment in the UK. You will have to pay for the IHS if your visa will be 6 months or longer in length. You need to pay the IHS fee even if you have private medical insurance. The charge will cover most medical expenses in the UK but will not cover dentistry costs or prescription medicines. The surcharge does not cover transport home if required in an emergency. Please note: if applying overseas, you will not get a refund for any overlapping IHS payments if you have already paid this as part of a previous visa application

**ATAS:**

If your course requires ATAS clearance please ensure that you provide your ATAS certificate with your visa application.

As your visa sponsor, the University of Bath has to ensure that you are not doing anything which breaches your immigration status. We have a legal requirement to inform the Home Office of changes to your student status such as not registering when asked to do so, not attending your course or failing to renew your visa if it is expiring and you are staying in the UK.
